

SECRETARY REPORT FROM 31.07.17 to 31.08.2017

Meeting with MD, JBVNL:

01.08.17: Sri Rahul Purwar, IAS, MD, JBVNL was invited at JSIA along with Chief Engineer, GM, ESE, EEES and his IT related team to deliberate on issues raised by JSIA from 3:30P.M. to 5:30P.M.

The President welcomed MD, and all senior officers of JBVNL, EC members & Past Presidents of JSIA and participants from Hazaribagh, Gumla, Ramgarh, Garwah, Latehar, Khunti.

Sri Ajay Bhandari, Master of Ceremony briefed about the previous meetings and said that many issues have remained unresolved due to negligence of the officers. He also said the tall claims of the Govt. to supply 24/7 power is yet to be fulfilled.

Sri Anjay Pachariwala appraised on the issues raised in the previous meeting in March'17, which the department have failed to resolve despite our reminders.

Sri Binod Tulsian, submitted suggestions on improvement of over all power supply and reiterated that until mind set of the officers would change, the consumers would continue to suffer.

Mr Rahul Purwar, gave power point presentation on future plans of the department and said that there is no dearth of Power in Jharkhand, but poor transmission network is the main hurdle to supply uninterrupted power. He said that many new substations would be installed within next few years under R-APDRP and work on laying of new transmission line across the state is under progress. He assured that problem of delay in issues of bills have been sorted out and henceforth, the agency would submit the bills & collect payment on the spot. He also directed ESE to ensure power supply through dedicated Industrial feeders to industrial consumers and minimize dilution of the same.

During Q/A session, MD patiently heard problems of members from Gumla, Hazaribagh, Khunti, Ramgarh, Garwah and Ranchi and directed ESE & GM of different circles to address the problems and take immediate action to resolve it within specific timeline.

Sri Arun Khemka, IPP proposed vote of thanks.

02.08.17: Sri Philip Mathew attended the meeting on NOC Expert Committee, at the office of the MS, JSPCB at 11:30 P.M. amidst presence of its members. Mr. K. Ravi Kumar, DI was also present in the meeting.

Matter of NOC of a unit near Baharagora area came up for discussion. The unit recycling paper, has made an investment of 25 crores, but NOC was rejected as it is within 200 meters of the forest area. However, the unit was asked to submit all documents to reconsider the case.

Sri K. Ravi Kumar was forthright to mention that JSPCB should not take rigid stance and come forward to help new upcoming industries by amending rules wherever possible.

Meeting with Commissioner, Mines:

18.08.17: Sri Vivek Tibrewal & Sri Aditya Biyani met Mr. Abbubecqer, Commissioner Mines, Department of Mines & Geology, at his chamber at Nepal House at 4.00P.M. and sought clarification on registration of Dealer's license for MSMEs under MMDR Act. After discussion the Commissioner assured to initiate action on following points.

1. Under state Minerals policy one time, on line Registration for all industries on payment of Rs. 25,000/- for procuring Minerals, including coal is mandatory. Process is yet to initialize awaiting final approval from the Industries & Mines department.
2. To consider MSME exemption on basis of consumption of coal up to 300 MT. JSIA was asked to submit supporting documents.
3. JSIA was asked to furnish supporting documents for exemption of Dealer's registration from any neighboring states.

Meeting with Director Industries:

23.08.17: President, Hony Secretary, Jt. Secretary & Mr. Keshav Chhawchharia met Sri K. Ravi Kumar, DI, at his chamber at 10:00 A.M. amidst presence of Mr. S.K.Bariyar & GM, DIC, on allotment of land for Engineering Cluster. DI said that 21 acres of land have been acquired, developed & notified by the Industries department at Sarwal village off Ring road near Rampur. He asked JSIA to immediately apply for required plot of land on line for allotment. He was categorical to mention that cost of land, around Rs30 lac per acre, would have to be born by the Company formed for the cluster, payable upfront or in 10, six monthly installments. He advised to register name of the company to apply for land on- line and later on SPV could be formed.

Sri Randhir Sharma & Sri Keshav Chhawchhari would work out the details of investment of cluster development & share it with prospective partners to initiate further work.

Meeting with GAIL(INDIA) Ltd. :

23.08.17: President, Sri H.P.Biyani, Sri C.K.Raipat, Sri Michel Mathew attended prospective Gas consumer's meet organized by GAIL(India) Ltd under aegis of CII at Hotel Green Horizon at 11:00 A.M. Mr Ashish Mathur, Convener, CII Infrastructure panel & MD, JUSCO gave welcome address, while Mr. Vinay Prasad, Zonal Chief GM, GAIL (India) Ltd apprised on their project of Jagdishpur-Haldia & Bokaro –Dhamra pipe line. He said that laying of gas pipeline would be completed phase wise by March,2020, for availability of **Natural Gas** through pipe line for Industrial as well as domestic purpose. He also said that Eastern part of India would be connected with the existing Gas grid of Western coast to the Central part of India. Dhamra LNG Terminal will be developed in the Eastern Coast.

Sri Pawan Sharma, GM, Marketing based in Ranchi, emphasized all prospective consumers to avail benefits of efficient, affordable, clean and environment friendly Natural Gas for their industrial use.

Mr Rajendra Prasad, Dy Director, Industries mentioned that GoJ has supported project of GAIL(India) Ltd with a sum of Rs.5 crore, which is pending for final approval.

Mr C.K.Raipat, gave concluding remarks and urged them to associate with local industries Association. Sri P.K.Biswas, Dy GM, Marketing-Gas gave PP presentation on usage of Natural Gas. Besides these projects would generate direct as well as indirect employment and would boost socio-economical development in Eastern part of the country. There would be immense opportunities for plastic industries to develop & meet their requirements of polymer pipes.

29.08.17: Mr Praful Kr. Dattani attended DRUCC meeting at the Chamber of DRM, Hatia at 11.00 A.M.amidst presence of other members of the committee. Sri Vijay Kumar Gupta, DRM chaired the meeting and apprised members on achievements by S.E.Rly. in 2016-17 as follows:

10. Proposal to run Express, Mail Trains in RNC – Lohardaga Tori line is at a very advanced stage and may start in near future.

12. Tele Medicine facilities made available at Bano Station through Video Conferencing.

14. Automatic Coach washing plant is operational at Hatia Station.
15. Mechanized Laundry of 2 Ton Capacity each is operational at Ranchi and Hatia Station solving long pending demand of used/dirty bedding problem.
16. 2 lifts at PF- 1 & 2-3 with 13 passengers capacity is operational at Ranchi Station.
17. Hatia – Yaswantpur Express Coaches have changed and are now as good as Rajdhani Express.
18. Hatia – Bandamunda doubling of line work already started (159 Kms.) and will take 4-5 years to complete.

New Works Sanctioned for the year 2017-18:

1. Provision of 2nd Entry at Ranchi Station from South side.
2. Rail Yatri Niwas to be converted into retiring rooms at PF-1 at Ranchi and will be operational within a year.
3. Underground water storing Tank of 2 lakhs gallon capacity at Ranchi Station for improving water supply.
4. Call 1323 for e-catering in trains even in trains where pantry car is available.
