**24.09.2019:** Meeting on single use plastic held on dated 24/09/2019 by Jharkhand State pollution control board at palash hall attended by Various plastic trade and manufacturing concerns, where government clarified government haven't imposed any new ban on new plastic item ,wants to reduce plastic consumption and increase plastic recycling through collaborative approach. Attended by Sri Aditya Lakhotia.

**26.09.2019:** Meeting with Labour Secretary attended by Sri Philip Mathew, Sri Anjay Pacheriwala, Sri Y.K. Ojha & Sri Keshav Chhawchharia.

We had discussed matter related to Onetime 10 years payment of factory licence fee. Secretary Labour agreed with our view that it is neither practical and also burdensome. He agreed to send proposal for Cabinet approval for amendment.

Matter related to registration of unorganized labour. It is clarified that units covered under ESIC/EPF will not come under this scheme.

**30.09.2019**: Seminar & Workshop on IPR at Jharkhand Govt. Mini Tool Room, Tatisilwai, inaugurated & attended by Sri Philip Mathew, President & attended by Sri Y.K. Ojha, Sri H.P. Biyani etc.

**15.10.2019**: Seminar & Workshop on Sabka Vishwas Legal dispute Resolution Scheme' 2019 at FJCCI, Chamber Bhawan, attended by Sri Anjay Pacheriwala.

Union Government has launched a OTS Scheme for settlement of pending dues and litigations. The scheme is very simple and attractive. Members having any pending show cause/appeal etc are advised to avail benefit of this scheme.

**11.10.2019**: Seminar & Workshop on Awarness Programme on CLCSS by MSME-DI at JSIA MSME-DI has conducted an Awareness Programme one CLCSS Scheme. It is an upfront grant upto 15.00 lacs on eligible plant & machinery purchased through Bank Term Loan.

**11.10.2019**: Seminar & Workshop on ERP by Neofuition Technosol Pvt. Ltd at JSIA. Neofuition Technosol P. Ltd. Ahmadabad proposes to hand hold MSME and encourage use of digital platform for managing business.

**14.10.2019**: Workshop on Single Window by Chief Inspector of Factories, Govt. of Jharkhand at JSIA. Many short coming in the portal was discussed and single window team assured to rectify the short coming.

**22.10.2019**: Zonal Railway Users Consultative Committee (ZRUCC) Meeting held on 22.10.2019 at Riviera Conference Hall near Rail Museum, Howrah. General Manager of S.E. Railway Mr. Sanjay Kr. Mohanty, AGM, Mr. Anupam Sharma, SDGM, Mr. Sankarsan Nayak alongwith other officials of Finance, Engineering, operation, Mechanical and I.G. Cum Principal Chief Security Commissioner Mr. S. Chandra Parhi were present.

On behalf of JSIA Mr. Binod Kr. Agarwal presented the following suggestions.

- 1. Train No. 18189 originating from Tata and Train No. 13351 originating from Dhanbad is beingcombined at Raurkela and run jointly from Rourkela to Alleppey. Both trains should run separately so that maximum local passengers can get accommodation.
- 2. Train No. 13307/13308 Ganga Sutlej Express from Ferozepur to Dhanbad Ferozepur. The demand for extending the said train to Ranchi is going on for a long time. Mr. Ashwini Lohani, the then Chairman of the Railway Board also agreed to this. Therefore, it is requested that the extension of Ganga Sutlej Express should be initiated. There is no train for one passengers of Ranchi district for Ayodhya, Barailly, Roorkee, Ambala and Firozpur. Ranchi is a State Capital of Jharkhand.
- 3. Stoppage of various Trains at Parasnath Railway Station: Parasnath is Holy pilgrimage destination of Jains of whole world. It is suggested to have stoppage of Train No. 12825/12826 Jharkhand SK Express, 12439/12440 Ranchi Rajdhani Express, 12817/12818 Jharkhand SJ Express. This will help the devotes who want to come to Parasnath from Rajasthan, Punjab, Utter Pradesh and Uttaranchal.
- 4. Bada Bamboo Railway crossing falls under Adra Division closes almost every time so, that a ROB is requested immediately.
- 5. An Under Pass between Kita and Jonha was constructed it is not as per specification and technically faulty resulting several accident which needs your immediate attention.

**22.10.2019**: Meeting with JSERC on Electricity Supply code review panel attended by Sri Anjay Pacheriwala. Draft proposal have been circulated for our comments/suggestions so that it can be discussed and finalized.
