SECRETARY REPORT FROM 11.11.2017 to 22.12.17

Workshop by RBI, Ranchi.

17.11.17: RBI Ranchi conducted two days workshop on MSMEs for capacity building by Bankers at Hotel Maple wood. Sri S.K.Agrawal, VP, & Sri H.P.Biyani attended the penal discussion with Bankers on 17th and raised the issues of loan under CGTMSE scheme, Credit ratings of borrowers by Banks. They also raised the point that the interest rate with SME is high which makes SME difficult to compete with large industries. Maximum cost of interest should not be more than 8%. Further, they also made the point that there should be uniformity in interest rate as different banks are charging different rates. Banks are also taking long time to disburse the loans. Finally, they requested that Quantum of fund to MSME should not be curtailed.

Meeting with IIA

20.11.17: A formal meeting was arranged between Indian Industries Association(IIA), an Apex body of MSME in North India and JSIA. Sri K K Agrawal, General Secretary of IMA visited JSIA on date at 3:30 P.M. JSIA was represented by Sri Yogendra Kr.Ojha, Sri ArunKr. Khemkha, Sri Deepak Maroo and Sri Anjay Pacheriwala. IIA would like to work on a joint program with JSIA. As both the Associations are accredited by NABET, a formal tie up could be more conducive for the benefit of MSME's and taking up issues of common interest at the national level. Both parties agreed to this. A draft MOU was discussed. JSIA members said that MOU will be discussed in the forthcoming EC Meeting and then will be formally signed by JSIA and IMA. Sri K K Agrawal was very grateful for the hospitality extended to him.

Meeting with Giriraj Singh, Hon'ble Minister for MSME:

24.11.17: Sri Deepak Maroo, VP, Sri Binod Tulsyan and Sri Ajay Bhandari represented at a meeting scheduled with Sri Giriraj Singh, Hon'ble State Minister of MSME at Aarogya Bhawan, Bariatu. They submitted a memorandum to the Hon'ble minister raising important issues. First, MSME 'Samadhaan' portal is a welcome step. However, it should not be optional but made mandatory for both MSME Suppliers (to upload their supply bills) and buyers(to upload their payment details).

Secondly, they pointed out that 20% purchase from MSME is not yet incorporated in GeM. Therefore, it was requested to keep alive 20% purchases from MSME in the new GEM System of purchases.

They also raised the point with example, that various departments under State Governments are putting conditions of very high EMD, and ignoring NSIC registration, thereby making it difficult for MSMEs to participate in tenders. The Minister assured to look into the matter.

Meeting of the State Level Selection Committee (SLSC) for National MSME Awards- 2016.

25.11.17:The meeting Chaired by Mr. S K Barnawal, IAS, Secretary Industries, with Director MSME DI and others. Ministry of MSME, GOI has announced a scheme known as "National MSME Awards 2016 in following 6 categories:

Meeting with Sri T. Nandkumar at JSIA.

29.11.17: Sri T. Nandkumar, IAS, recently appointed as Chairman Development Council Jharkhand visited JSIA. Sri Mahesh Poddar, Hon'ble Member of Parliament also graced the occasion. He introduced the young team of JSIA. Discussion were deliberated on the present status of industrial scenario in Jharkhand. Sri Siddharth Jhawar raised the point that his firm is not receiving the Input Tax -

Credit on Export items under GST System. This is getting delayed. This credit is being used as Working Capital for his firm. As a result, his business is getting affected. Sri Nandkumar said that it is still early days in GST, and all issues relating to GST would be overcome in near future.

Sri Nandkumar admitted that most of the time of top officials are devoted in organising events. As a result, the core work is getting affected. He said he had already made a point on it in his meeting. Sri Deepak Kr. Maroo, Sri Siddharth Jhawar, Sri Bikash Singh, Sri Arun Khemkha, Sri Anjay Pacheriwala and others from JSIA and Sri Ranjit Garodia and Sri Kunal Ajmani from FJCCI were present.

Meeting of PMEGP:

05.12.17: Meeting was chaired by Sri Anjani Kumar Mishra, Addl. Commissioner. The discussion was held on following agenda:

- 1. JBVNL was directed to ensure issue of monthly electric bills to its consumers against issue raised by Mahal Industries, Tatisilwai,
