08.09.2020: State Advisory Committee Meeting (JSERC):

1. JSERC SAC was held on 08/09/2020. Anjay Pachariwala, Hony. Secretary attended the Virtual Meeting and raised various matters and Comments/Objection on Tariff Proposal.

Webinar of DPS and fixed charge for 3 months.

With our effort, JSERC has directed JBVNL to provide relief to their consumers in DPS and fixed charges for three months. The same is directed to be adjusted in the energy bill of October' 2020.

2. Public hearing on Fixation of JBVNL Tariff : JBVNL had proposed a very steep hike in the Electricity Tariff for the year 2020-21.
 - JSIA Electricity Committee strongly objected to their proposal.
 - With collective efforts of all stakeholders, we succeeded in stalling the tariff hike proposal.
 - Further, it has been mandated that JBVNL has to ensure power supply of minimum 21 hours/day. If JBVNL fails to meet the minimum power supply, proportionate reduction in fixed charge will be done.
 - Load factor rebate above 45% has been introduced.
 - Meter rent has been abolished .
 - Introduction of demand based tariff for Commercial Consumers.

29.09.2020: Meeting with Commissioner Service Tax

President & Hony. Secretary met Commissioner Central Excise & Service Tax regarding Service Tax related notices for the year 2014-15. During discussion, he showed his helplessness to grant time but assured to provide full co-operation during course of show cause hearing.

06.10.2020: Meeting with Labour Minister – Shri Satyanand Bhokta

President, Jt. Secretary met Labour Minister regarding increase in Minimum Wages retrospectively from April' 2020. He assured to review the same.

07.10.2020: Sri Ranjit Tibrewal, PP attended PCC meeting in the chamber of MD, JIADA amidst presence of other committee members. Total 71 Application for project clearance were placed before the committee for approval and 70 projects were cleared & 1 cases not considered.

EPF :

Many members have been served notice by Provident fund office cleaning delay payment interest and penalty for period related to 1999 onwards.

We have lodged strong protest with the DG EPFO New Delhi, MSME Ministry and PMO.

Our objection has been taken seriously by MSME Ministry and forwarded to Director MSME, Ranchi to submit their report.
