- 4. Parcel Booking: Chief Parcel Supervisor posted at Parsal Office to be contracted in case of any problems in booking parcels. Name & Mobile no. of concerned person will be displayed at parcel office in future.

DRM also informed that no new trains can be started for south till doubling of Banda Munda line is completed which is expected by 2024.

Aadhar Facilitation Centre at Ranchi Station is operating since 22.09.2022. Piska is under development and work is started by laying Foundation Stone on 26.09.2022.

ATVM and UTS for unreserved tickets is available at Ranchi/Hatia stations. 4 Nos. New Water Coolers, 2 each at Ranchi & Hatia are operational.

Since New Trains are not possible, Railways are trying to accommodate heavy rush by adding extra coaches 336 extra coaches are added in 237 trains from July to Nov.22.
