21.02.2024: 1st Meeting of the State level Committee Meeting under the Chairmanship of Chief Secretary, GoJ held in his conference room on Standardization for the state of Jharkhand. 11.12.2023: Meeting with Secretary Industries Attended by – President Sri Anjay Pacheriwala.

The issues discussed were – Non functioning of MSEFC, Subsidy disbursement, Food Policy, Textile Policy, appointment of Regional director at JIADA.

Secretary Industries assured that Food Policy and Textile Policy will be cleared soon. He also assured to look into the other matters.

08.02.2024: Meeting with Director of Industries, GoJ on issues related to MSME. Attended by President Sri Anjay Pacheriwla, Hony. Secretary Shivam Singh.

We briefed him about JSIA and discussed matters related to subsidy disbursement and nonfunctioning of MSEFC.

12.02.2024: Meeting with Jt. Director Department of Industries organized on Vehicle Scrappage Program. Attended by our President Shri. Anjay Pacheriwala.

GoJ is planning to formulate vehicle scrappage policy for promotion of vehicle scrappage units in the state. The government is also exploring the possibilities of including such units under JIIP Policy

15.02.2024: Meeting with Secretary Industries, Project Bhawan, Dhurwa at 1.00 pm. Attended by President Sri Anjay Pacheriwala.

There was discussion regarding lapsed policies, subsidy disbursement, MSEFC, etc

JHARKHAND GOVT. TOOL ROOM:

04.11.2023: Stake Holders meeting at Jharkhand Govt. Tool Room, Tatisilwai. Attended by – President Sri Anjay Pacheriwala.

20.06.2024: Meeting organized by Sri A. Dasgupta, Senior Executive Officer, IRMA along with Jharkhand State Government Tool Room, Tatisilwai, Ranchi, attended by Sri H.P. Biyani. Discussion was held on the problems and prospects of Refractory Clusters of Jharkhand and West Bengal and possible areas of intervention.

We discussed the problems being faced by Refractories in the state and deliberation was held on the same. Refractory cluster is functional in Asansol by WB MSME refractory units whereas two approved clusters in Jharkhand (one in Dhanbad Chirkunda Area and another in Ranchi – Ramgarh area) could not take off till date.

01.07.2024: 12th Governing Council meeting of Jharkhand Government Tool Room (JGTR) held under the Chairmanship of Secretary Industries, GoJ. Director Industries, Joint Director & HOD MSME DFO and other council members were present. Shri Randhir Kumar Sharma represented JSIA for the meeting.

For the FY 2023-24 JGTR Ranchi & Gola excess of Income over expenditure Rs.147.62 Lac and for JGTR Dumka it is Rs. 90.88 Lac

As a capital expenditure Ranchi and Dumka tool room is planning to install CNC Lathe, CNC Milling, Laser Cutting Machine, CNC Plasma Cutting Machine, 3D Scanner etc.

4th Annual General Meeting of Jharkhand Government Tool Room was also conducted. Achievements of JGTR, Audit report acceptance, Recurring Budget and Capital budget were discussed.

23.08.2024: 12th Governing Council meeting with 4th AGM meeting of Society Jharkhand Government Tool Room (JGTR) held under the Chairmanship of Secretary Industries-cum-Chairman, GoJ, Project Bhawan, Dhurwa. Attended by E.C. Member Sri Keshav Chhawchharia.

Shri M. K. Gupta, Principal presented the accounts and reported a surplus of 1 crore in the last financial year. There was a proposal to reduce the number of seats for welders citing lack of students despite 100% placement record in the said trade, JSIA objected to this and pointed out that industries are facing acute shortage of welders. The board agreed to our demand and rejected the proposal to reduce the seats instead focus on getting more students for the trade.

MEETING WITH THE DIRECTOR, MSME-DEV. & FACILITATION OFFICE:

01.09.2023: Meeting via Video Conference on PM Vishwakarma Scheme by the Ministry of MSME scheduled to be launched on 17th September. Attended by – Hony. Secretary, Sri Shivam Singh.

It was discussed that the ministry is expecting Associations to work as Ambassadors to make people aware of the Scheme. Aimed at moving people from entrepreneur to enterprise and reaching out to every village.

Recognitions to participants will be in the form of –

- Vishwakarma Certificate & ID Card.
- Credit Support.
- Skill up-gradation.
- Toolkit Incentive.
- Incentive for Digital Transaction.
- Marketing Support.

Program will consist of a 5 to 6 days skill-based training plus additional one day training at bank. Interest subvention is applicable for the scheme.

Interest capping maximum at 13% via CGTMSE. The scheme will not be applicable if any family member (Husband/Wife/Unmarried Child) has already availed any such scheme in last 5 years. Aadhar authentication will be done for such checks. Also, if any family member is a Govt. employee, then it will not be applicable. Total scheme outlay is 13000 Crore. Verifications shall also be done by Gram Panchayat Head/ULB Executive head. Total 18 trades such as Carpenter, Boat maker, Iron/Metal based worker, Mason, Cobblers, Broom/Coin Weaver, Tailor, Fishing net maker, Doll & Toy maker, Potter, Goldsmith, etc have been identified for the scheme. Website: pmvishwakarma.gov.in. No money needed for registration.

03.11.2023: Sri Surendra Sharma, Assistant Director, MSME-Dev. & Facilitation Office, Kokar, Ranchi attended the meeting at JSIA with Hony. Secretary Sri Shivam Singh & Sri H.P. Biyani. They had a detailed discussion on Udyam Porting and the issues being faced due to change in mobile no. JSIA wrote to the MSME ministry with probable solutions.

09/10-11-2023: Two Days Workshop/Seminar on Export & Import & GeM. Organised by MSME-Development & Facilitation Office, at Holiday Home, Kanke Road. Attended by – Past President Sri Philip Mathew, Hony. Secretary Sri Shivam Singh & Sri Randhir Kr. Sharma.

GEM – Detailed presentation was given on GEM. They have raised an important point not to send any documents directly to buyer channel it only through GEM Portal in case a dispute is raised.

Sri Uday Bhan Singh, Sr. Superintended of Post Ranchi Division briefed the audience about post office as a medium for export. His team briefed about the various options through which exports can be done directly through authorized post office. In Ranchi these are 3 post offices equipped to handle exports. Item with weight upto 35 Kgs can be sent through post office.

19/20-01-2024: MSME Committee & Jharkhand State Chapter, PHDCCI along with The Office of the DC-MSME, GoI organized a Two-Day National Level Intellectual Property (IP) Yatra Programmes in Audrey House attended by Hony. Secretary Sri Shivam Singh.

The information shared is as follows –

Delhi Mumbai Kolkata Chennai and Ahmadabad have patent offices.

- A. Trademark 10 years whereas Patent 20 years from date of filling. Annual reports have to be filed and it cannot be continued beyond 20 years. Provisional patent can be filing for patents which is under process and time is given to file the final specifications. Patent can be filed for Product or process or improvements.
- B. IPFC Intellectual property facilitation center. PhDCCI has also applied to become IPFC. WIPO World IP Organization is the main controlling agency. Mr. Murthy NLU Ranchi has offered to provide assistance to MSMEs if they want to file for trademarks within the grant amount of Rs. 10,000.00 Provide by MSME-Dev. & FO.

We were briefed about the various methods of implementation of Lean manufacturing. It was informed that a consultant will be appointed at a discounted cost and he will study the processes and take about 6 months' time to implement lean in a manufacturing organization in the first stage. Government scheme and subsidy in this matter was also discussed.

18.06.2024: Meeting with Director (GA & TP), Sri Vinamra Mishra, MSME, GoI, New Delhi & Director, Sri Inderjit Yadav, MSME-FO, Ranchi, Dy. Director of MSME Offices, Ranchi at JSIA Office. Attended by President Sri Anjay Pacheriwala. We discussed at length the problems being faced by MSMEs and also submitted our representation regarding the same.

07.08.2024: Meeting with Secretary, MSME, GoI at Project Bhawan, Dhurwa, Ranchi. Attended by President Sri Anjay Pacheriwala & Hony. Secretary Sri Shivam Singh, PP Sri Philip Mathew and Sri Sunil Agarwal.

We deliberated on the key points which were causing hindrance in growth of MSMEs in the state. A detailed report on the same was also submitted by our side. Various other Associations also expressed their concerns and problems related to MSMEs.

06.09.2024: Meeting was held on various schemes of MSME introduced very recently. These schemes seem beneficial to the MSMEs' and covers various sectors and activities. Details are available at JSIA Office. Interested Members can take benefit of the same.

MEETING WITH JSPCB:

18.12.2023: Meeting with JSPCB on establishment of new industry at Plash Auditorium, Near Forest Officers Colony, Doranda, Jharkhand State Pollution Control Board, Ranchi. Attended by IPP Sri Philip Mathew.

Sighting criterion for new industries – discussion was held on distances from NH, SH, Forest, Railway, Water bodies, rivers etc. and certain decisions were taken.

MEETING WITH LABOUR DEPARTMENT:

29.09.2023: Labour Wage revision meeting. Attended by E.C. Member, Sri Randhir Sharma. We objected to the abnormal hike proposed.

06.12.2023: Meeting with Labour Enforcement Officer on 75% reservation matters. Attended by – President Sri Anjay Pacheriwala & Sri Randhir Sharma, Sri Keshav Chhawchharia. We raised our problems about non availability of Residential Certificate by employees and lack of clarity about definition of local person.

11.12.2023: Court Case filed against 75% Reservation at High Court of Jharkhand. The same could not be taken up in December as Chief Justice has retired in Dec.2023. We shall mention for urgent hearing once the new Chief Justice joins the court.

05.01.2024: Meeting with Employment Officer, Sub Regional Employment Exchange, Ranchi on Organizing Workshop for 75% Act. Attended by – Hony. Secretary Sri Shivam Singh & Sri Randhir Sharma at FJCCI, Ranchi.

The employment officer briefed the house about process of registration and displayed the various modules of the website.

New recruitments must be uploaded in the website. Option to regularize backlog from 13 Sept. 2022 (After Act came in to force) is also given on the portal. There was objection on various grounds of the act however he informed that these are policy matters and he is not authorized to comment on them.

The focus was mostly on Apprentice act. Rs. 7,500.00 per apprentice for 3 months for 500 hrs of training. 2.5% to 15% of total employees. This includes contractual workers. Service Sector has also been included in apprentices act.

14.05.2024: Meeting with Jt. Labour Commissioner on Minimum Wages. President Sri Anjay Pacheriwala and Sri Keshav Chhawchharia attended the meeting. We opposed to the abnormal increase in Minimum Wages and submitted our objections.

Labour Department requested other Members to submit their suggestion in writing for consideration.

It was assured to meet again on this issue so that a Common Consensus can be reached. It was agreed by all stakeholders that a scientific formula be adopted to fix the Minimum Wages.

24.06.2024: Meeting with Labour Commissioner, on Minimum Wages was held in labour office, Doranda. Attended by President Sri Anjay Pacheriwala & Sri Keshav Chhawchharia.

We once again voiced our concerns regarding abnormal increase in the Minimum Wages. We had also raised the issue of ability of a MSME to pay the abnormal hike. Labour Commissioner assured to consider separate Minimum Wages for MSME.

MEETING WITH STATE GST/CGST:

07.02.2024: Meeting with Chief Commissioner, Central GST, Ranchi on GST Grievance Redressal Committee (GRC) for the state of Jharkhand. Attended by President Sri Anjay Pacheriwala, IPP Sri Philip Mathew. We have suggested to include Petroleum Products, Electricity duty and Natural Gas under GST.

03.09.2024: Meeting with Principal Commissioner – GST: Various issues were discussed during the meeting and many matters related to non-cooperation by GST Officials were resolved. JSIA raised the issue of penalty being imposed for clerical mistakes. Also timely availability of SGST payment certificate and no dues certificate, as required for claiming incentives under JIIPP was raised.

MEETING WITH STATE LEVEL BANKER'S COMMITTEE(SLBC):

24.08.2023: 84th Meeting of State Level Banker's Committee (SLBC) **at -** Hotel Radisson Blu, Main Road, Ranchi. **Attended by** – Banking Sub Committee Chairman Sri Sachin Kejriwal, Co-Chairman Sri H.P. Biyani & Hony. Secretary Sri Shivam Singh.

Some relevant information shared was – Insurance for person – Rs. 20/Year – 2 Lakhs & Rs. 356/year - 4 Lakhs under PMJBY & PMJJBY Schemes. RBI has recommended inclusion of certain chapters in school curriculum for financial literacy. Udgam Portal for dormant / unclaimed accounts is launched by RBI.

DG – CID – Anurag Gupta shared information regarding cybercrime. KYC was pending towards fraudulent accounts. Digital footprints is difficult to trace due to delay in IP address provided by banks. Proper & timely response is important to track. He further suggested enhanced security features for ATMs like AI can be used for detecting suspicious activities.

Ajay Kr. Singh (Principal Finance Secretary) in his speech mentioned that suggestions for policy for subsidy is welcome by the Secretary. He also informed that digital Bank Guarantee is being introduced very shortly in 2-3 months by GoJ.

Unique Registration Number (URN) to all new as well as existing MSMEs A/c.

29.11.2023: 85th Meeting of State Level Banker's Committee (SLBC) at Hotel Radisson Blu, Main Road, Ranchi. Attended by Hony. Secretary Sri Shivam Singh.

NABARD pointed out that current capacity of food grain storage is 12% of the total production, hence there is scope for Warehousing projects. 25-35% subsidy from GOI is available.

As per RBI data there has been little increase in the no. of MSMEs in the state from 5.9 lakh in Sep 2022 to 6.35 lakhs in Sep 2023. RBI is also conducting a survey of about 10,000 units all over India of which 251 units have to be surveyed from Jharkhand for policy making.

GOJ is planning to launch Guruji Student Credit card with attractive interest rate of 4% for higher studies. Remaining interest will be paid by State on quarterly basis.

Chief Secretary Finance informed that in the upcoming MSME policy capital subsidy has been increased from 25 to 40%.

15.02.2024: State Level Banker's Committee meeting at Project Bhawan, Dhurwa at 10.40 am. Attended by Hony. Secretary Sri Shivam Singh

Production of fish, fig, strawberry, dragon fruit, etc is being promoted currently. Registering Products under G.I. is important. Rural go-downs may pick up pace in the future. There is a plan to cover 10 Lakh hectors of water reservoirs by Solar panels in the coming future.

RBI informed that E-Bank Guarantees are now being issued for tenders as SD PBG etc. We asked about the list of bank's issuing E-Bank Guarantees and were told that we will be informed about the same shortly.

Finance secretary ensured about renovation of roads in the rural areas. He asked to be provided with a list of such roads which needs strengthening or up gradation.

14.08.2024: 88th Meeting of State Level Banker's Committee (SLBC) at – Project Bhawan, 2nd Floor, Dhurwa, Ranchi. Attended by – Co-Chairman, Banking Sub Committee Sri H.P. Biyani & Hony. Secretary Sri Shivam Singh.

Discussion was held on the performance of various banks during the quarter. Focus mainly was on agricultural sector and waiver of loans for farmers. CD ratio national average stands as 86.5% whereas for Jharkhand it is at 49.57% only although 10% higher YoY.

Internationalization of INR was again discussed at length and countries like UAE and Russia have started accepting INR as a currency for bilateral settlement. Helpline no. 1930 for any digital fraud is being strengthened for faster action.

14.08.2023: 59th Meeting of the Empowered Committee on Micro, Small and Medium Enterprises (MSME) at – RBI Campus, Kutchery, Ranchi Attended by: Hony. Secretary Sri Shivam Singh & Shri H. P. Biyani.

There is a 20% decline on YoY on MSME Registration. Bad Loans/NPA high with few banks for MSME loans. For units with Zed Certification 10% discount on CGTMSE fee. Normally 75%-85% risk coverage in CGTMSE fee SIDBI plans to increase additional 10% by assistance from Govt. of Jharkhand. RBI has requested JSIA to conduct awareness on TReDS.

Udyam Registration Drive is being conducted by banks. Problem being faced in migration from Udyog Aadhar to Udyam due to Mobile No. not updated by the entrepreneur. A question was raised if bankers can update the mobile no. in such cases which is currently being handled by Champion Portal or MSME (needs confirmation). A platform by the name of Udyam Assist. Platform is existing for units not having PAN or GST.

07.11.2023: 60th RBI Meeting of the Empowered Committee on Micro, Small and Medium Enterprises (MSME). It was attended by Banking Sub Committee, Co-Chairman Sri H.P. Biyani & Hony. Secretary Sri Shivam Singh.

- > Stress on MSME Development. 20% YoY growth on Loan to MSMEs.
- Letter which was written by JSIA to MSME ministry was also highlighted by us.
- ➤ CGTMSE Scheme implementation by banks is seen as increase in unsecured Loan. Therefore, banks avoid it to same extent. However, it was clarified that CGTMSE is a secured loan.

Some banks are taking the excuse of wrong date submitted for the meeting. This was strongly condemned by the Chair. He pointed out the long-term implications to the extent of wrong policy being made since RBI and Govt. are following this date through antardrishti portal.

UNIDO – UN Industrial Development Organisation Credit facilities in MSME cluster. Cluster to be identified by each lead banking sector and they should adopt at least one MSE cluster. MSME- Dev. & Facilitation Office has identified some clusters through KVIC. 5-6 clusters are expected to come up in 3-4 months as per MSME- Dev. & Facilitation Office.

07.02.2024: 61st RBI Meeting of the Empowered Committee on Micro, Small and Medium Enterprises (MSME). Attended by Hony. Secretary Shivam Singh at RBI, Ranchi Briefs about the meeting –

- 24% increase in YoY for Loans to MSMEs
- MSME DFO has got the authority to update the mobile no. for MSMEs willing to shift from Udyog to UDYAM and having difficulty due to wrong mobile number. Ranchi & Dhanbad branch have this authority currently.

- Total outlay of loans to MSME is Rs.35,000/- Crores.
- A target has been set to give 60% of total lending of MSEs to Micro Enterprises

CGTMSE now has hybrid coverage. CGTMSE rates have also been reduced as under

There is a provision of reimbursement of CGTMSE fee in MSME Policy 2023 of Jharkhand.

03.06.2024: 62nd RBI Meeting of the Empowered Committee on MSME on 03.06.2024. Attended by Co-Chairman, Sub Committee Sri H.P. Biyani & Hony. Secretary Sri Shivam Singh. The following points were discussed:

- a) Annual Service fee paid for CGTMSE by MSEs can be claimed by the borrower from the Industries Department, GOJ.
- b) If a unit is exempted from CGST Act based on turnover. Loans to such units are classified as PSL and Udyam Assist Platform is the registering authority instead of Udyam in such cases.
- c) MSMEs were facing problem in migration from Udyog Aadhar to Udyam. This issue was raised by us. The same has now been resolved.
- d) The MSME on it's letter head has to request the MSME field officer on their email ID. So they can change their mobile no. along with their Aadhar through email or Champions Portal. Self-certified Aadhar/PAN dcdi-ranchi@dcmsme.gov.in along with old email & old mobile number is also to be provided for updation.
- e) JSIA raised queries related to BG, RBI will consult with their Legal department and revert to us.

We also raised concerns <u>regarding cyber fraud in exports</u>. The Committee heard the matter and deliberated on the same.

07.08.2024: 63rd RBI Meeting of the Empowered Committee on Micro, Small and Medium Enterprises (MSME). Attended by Co-Chairman, Banking Sub Committee Sri H.P. Biyani at RBI, Ranchi.

- a) The last submission regarding queries on B.G. submitted by JSIA has been officially replied by RBI after referring to their Policy maker's levels. The response in this regard was not found satisfactory by us and we're further exploring how we can make improvement in this regard.
- b) During this meeting it was clearly felt that GOI is regularly issuing guidelines and structure to improve MSME health and create new Enterprises. GOI is now insisting Bankers to ensure that 60 to 90% of total exposure of bank loans should go to Micro loans, which is aimed at creating self-employment.
- c) Now banks are duty bound to report to SLBC and RBI without fail regarding revival & rehabilitation of sick MSMEs which was always mandatory to be reviewed by every bank on state level but has always been a weak area.
- d) RBI specifically asked how JSIA can help in internationalization of INR. Incase members, especially exporters so desire, we can request RBI for one educating seminar / webinar on this latest topic.

11.08.2023: 14th Provident Fund Regional Committee Meeting of Jharkhand State at Nepal House Campus, Ranchi Attended by – Shri Randhir Kumar Sharma.

Presently we have two offices at Ranchi & Jamshedpur. Ranchi covers 21 districts and 03 districts under Jamshedpur. As a new development EPFO will now have access to the GST Portal.
